Council Meeting Minutes
August 7, 2017

A regular monthly meeting of the Clarksville Village Council was held August 7, 2017 at the Clarksville Village Hall. President Amy Byers called the meeting to order at 7 pm.

Other Council Members present – Trustees Bonnie Main, Robbie Mutschler, Patricia Reser, Allen Sheldon, Brad Clark, Treasurer Rose Barratt, and Clerk Shari Clark. Absent - Trustee Joseph Graham.

Public comments were heard.

The minutes of the July 10, 2017 meeting were read and approved.

Motion by Mutschler and supported by B.Clark to pay monthly bills totaling \$3,907.33. Motion passed.

Reports were read by Treasurer Barratt, Street Commissioner Reser, Sewer by B.Clark, *Ex Officio* Planning Commissioner Main, and Clerk S.Clark.

Motion by Mutschler and supported by Sheldon to accept the following bids: Murray's Asphalt Maintenance 1.5"asphalt overlay of First Street from Cross to Ferney Street \$7,991.00 & McCormick Street from Main to Broad Street \$6,877.00. Jordan Smith Concrete Construction \$5,547.00 to remove and replace sidewalk on Main Street north of Cross to Ferney Street. All in favor, motion passed.

Motion by Mutschler and supported by Main to authorize Patricia Reser & Chris Atwell to place framed photos of former Ox Roast Grand Marshalls for permanent display in Village Hall. Motion passed.

Orin Mutschler submitted his resignation from Planning Commission effective 8/2/17 due to current location in Reed City.

Motion by Brad Clark and supported by Bonnie Main to adopt Ordinance #71 Supplement S-3 to Code of Ordinances. Upon Roll Call all voted "Aye". Absent: Joseph Graham. President Amy Byers declared Ordinance #71 adopted. This Ordinance shall be published in its entirety and be effective immediately.

Motion by B.Clark and supported by Mutschler to authorize up to \$1,000.00 expense to replace toilet & sink in restrooms. All in favor, motion passed.
